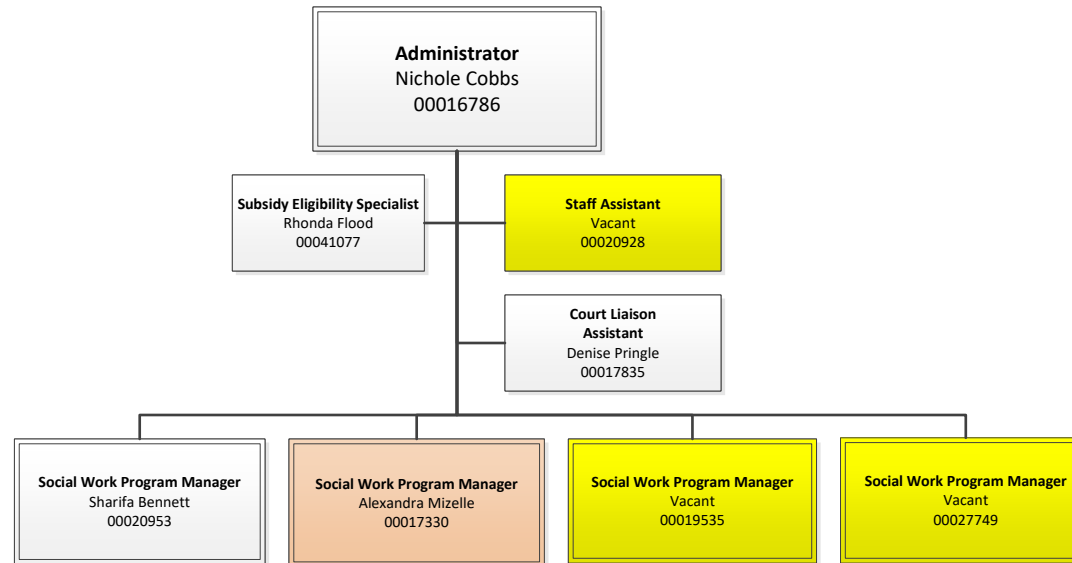




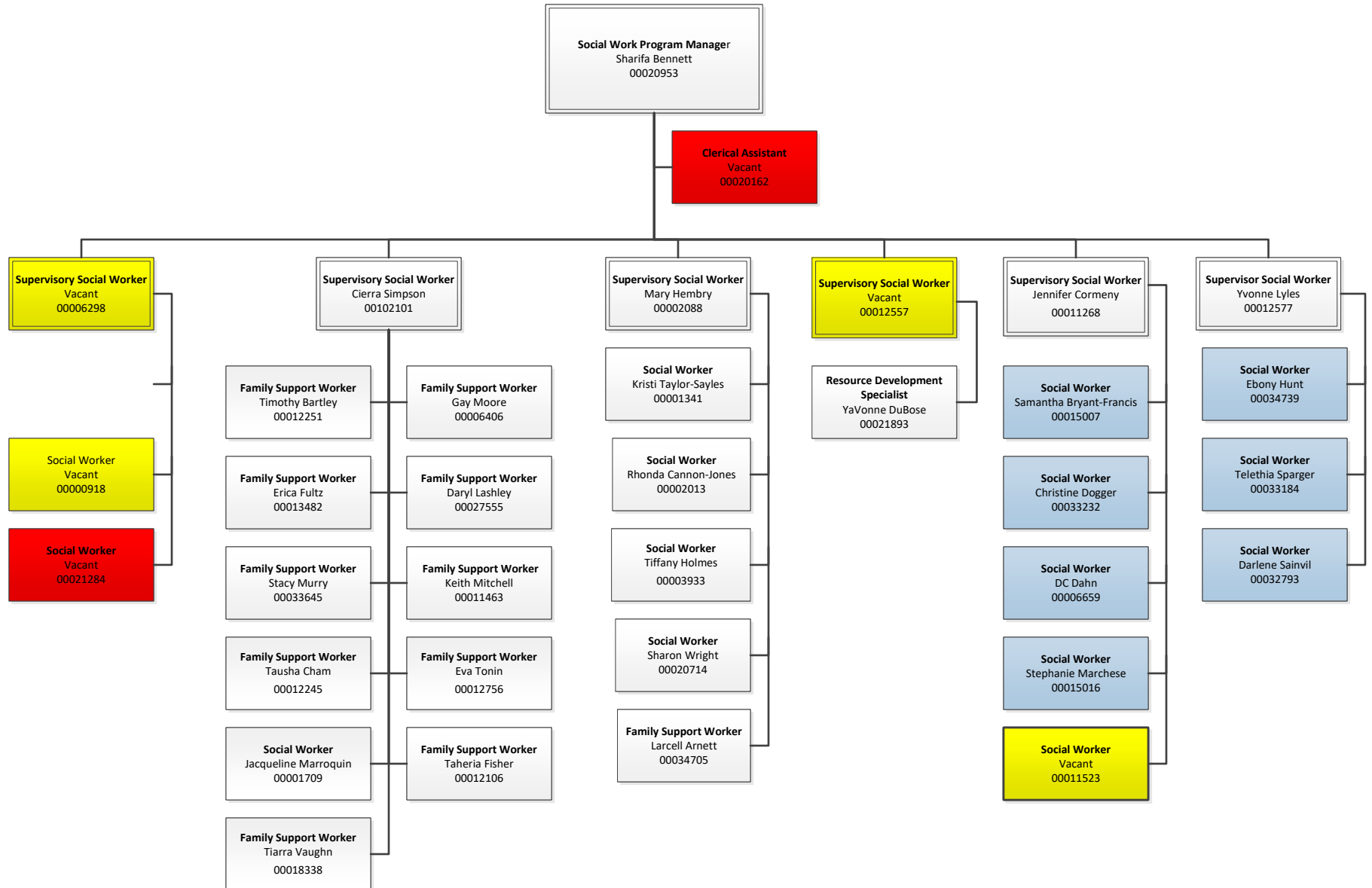




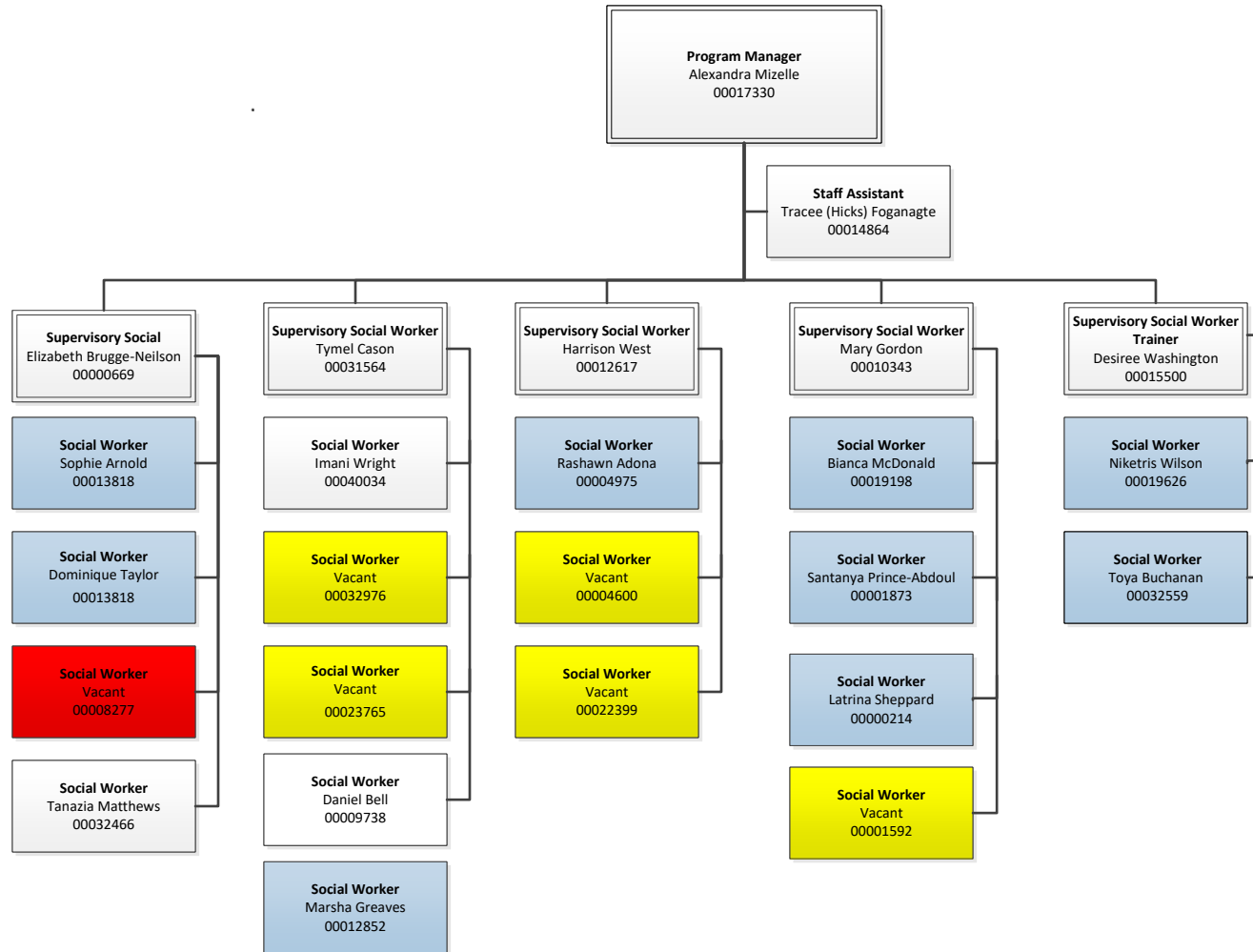
Out-of-Home Clinical Case Management and Support Administration



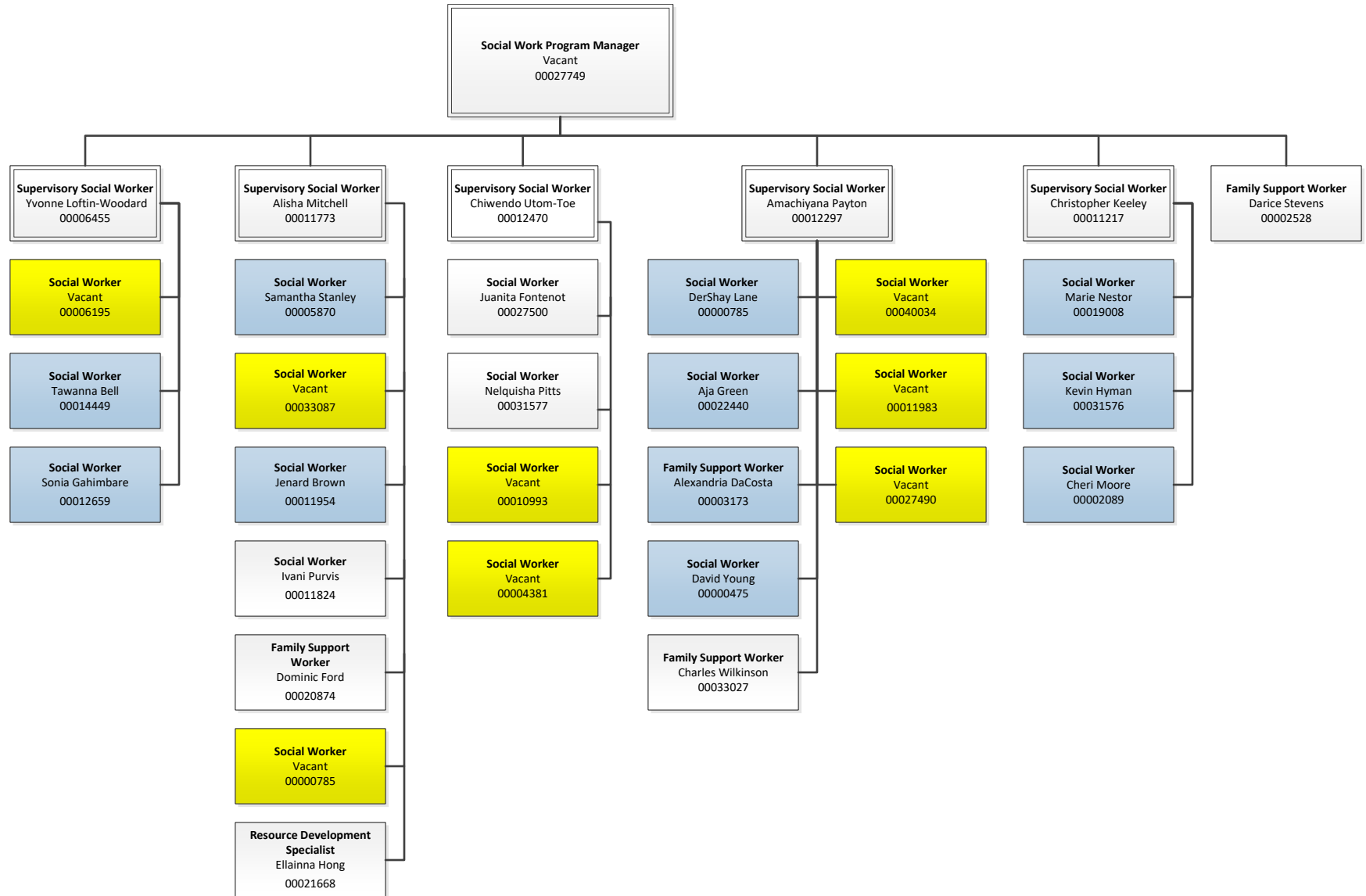
Out-of-Home Clinical Case Management and Support Administration: I



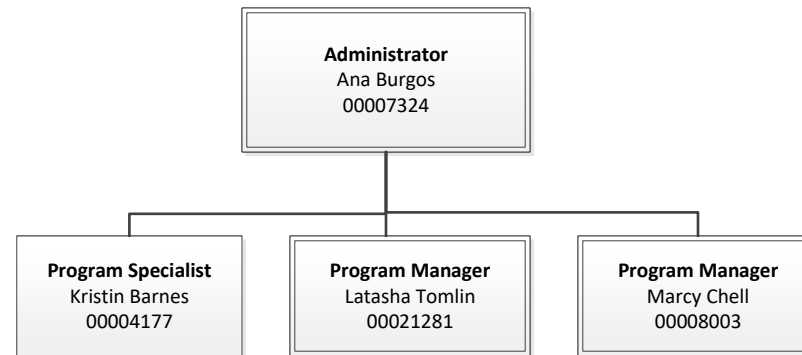

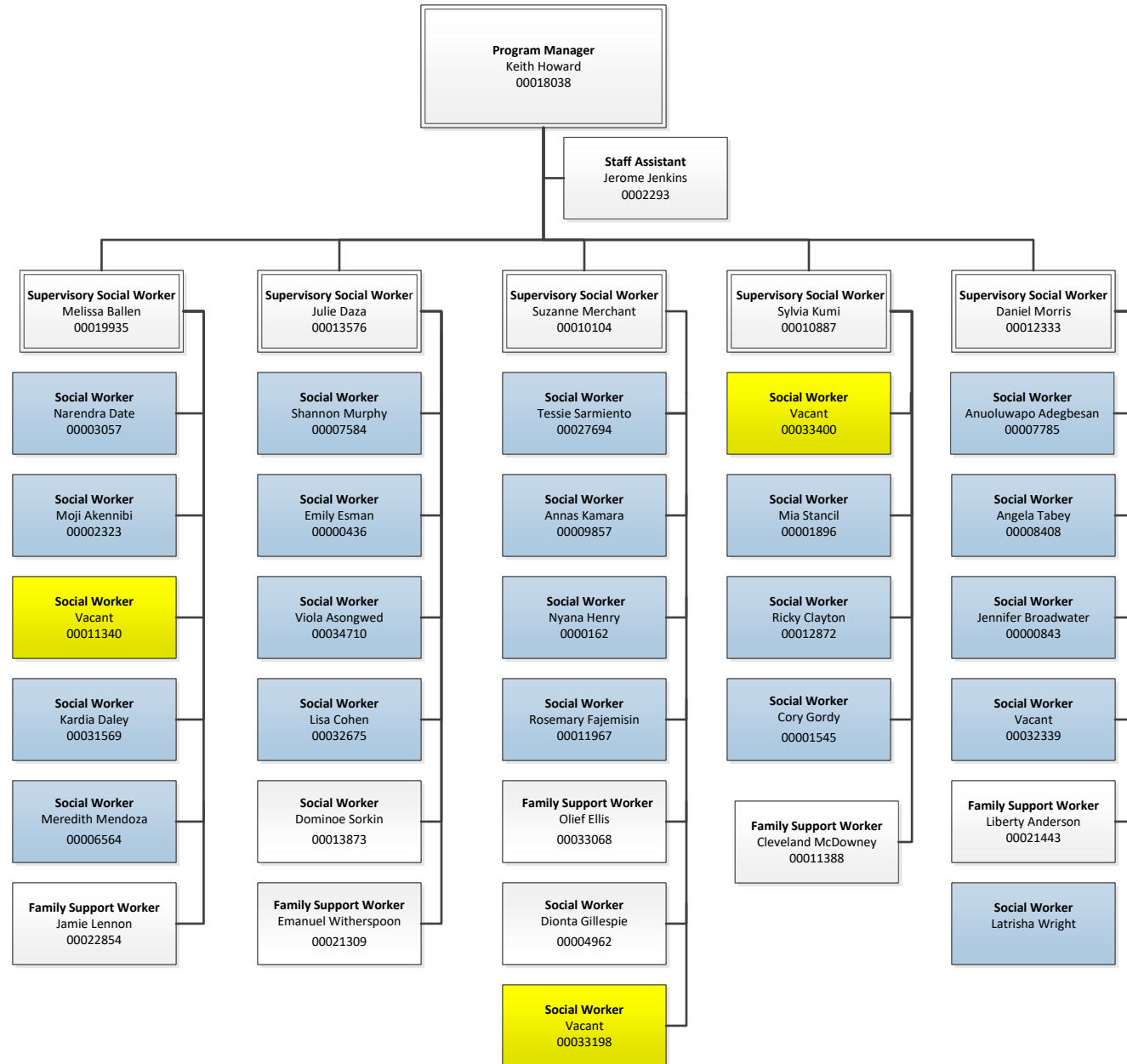
In-Home Clinical Case Management Support Overview



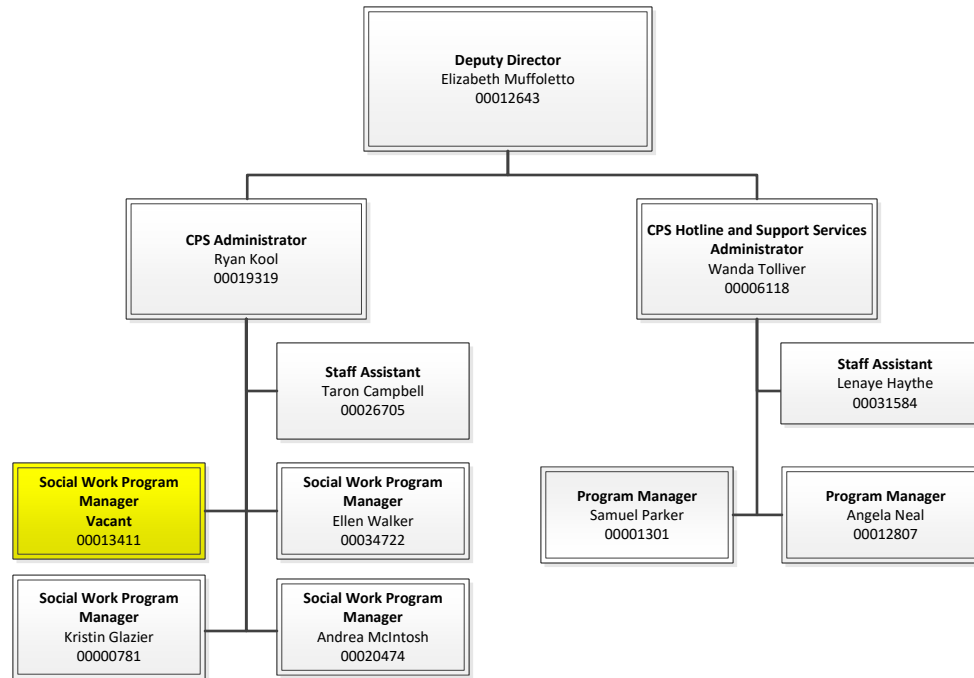

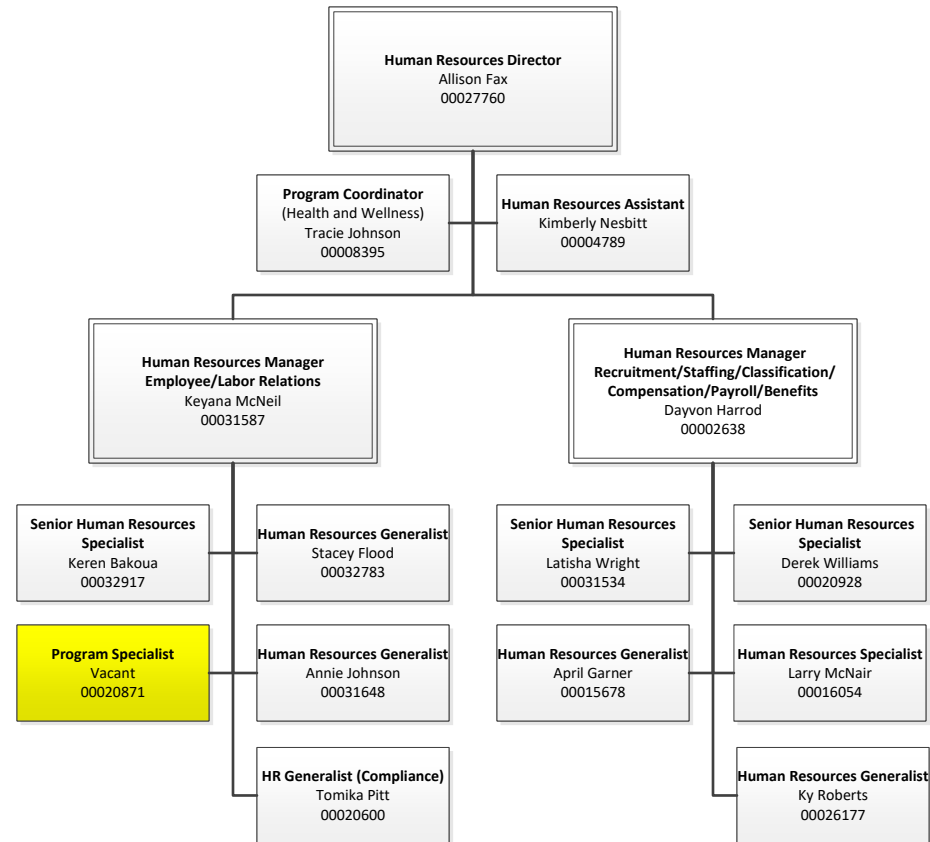
ODDA: Chief Administrative



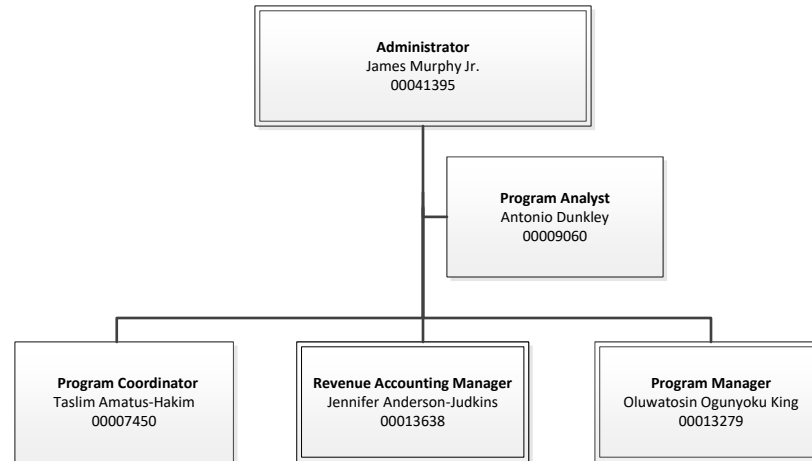
ODDA: Office Child Information Administration

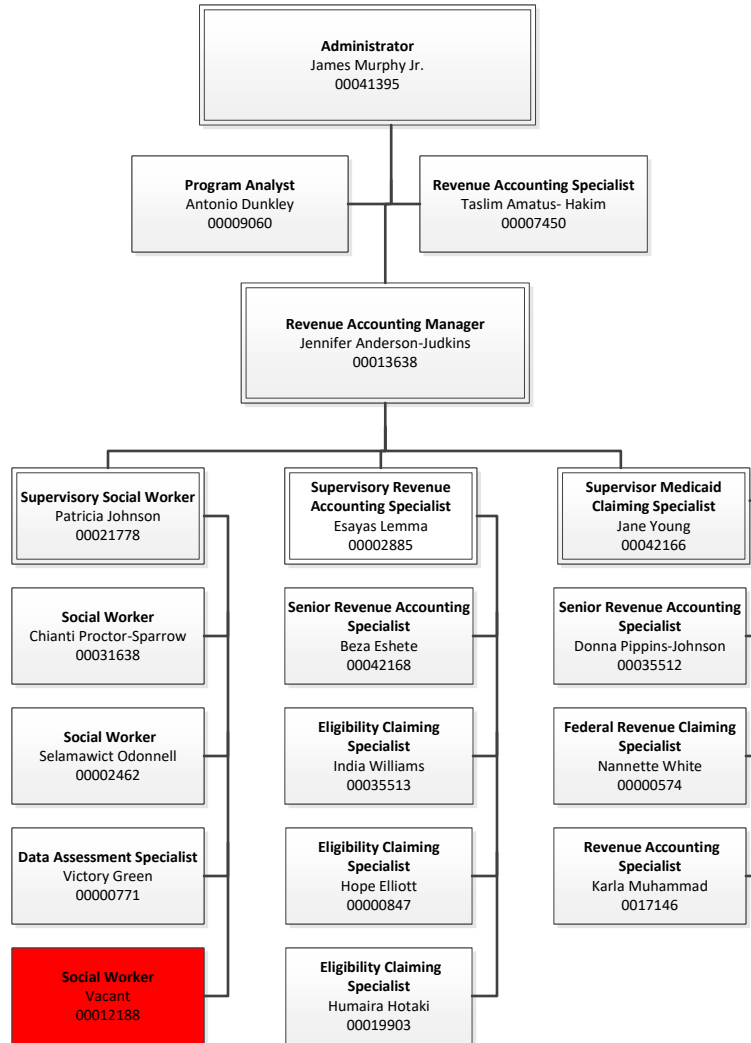

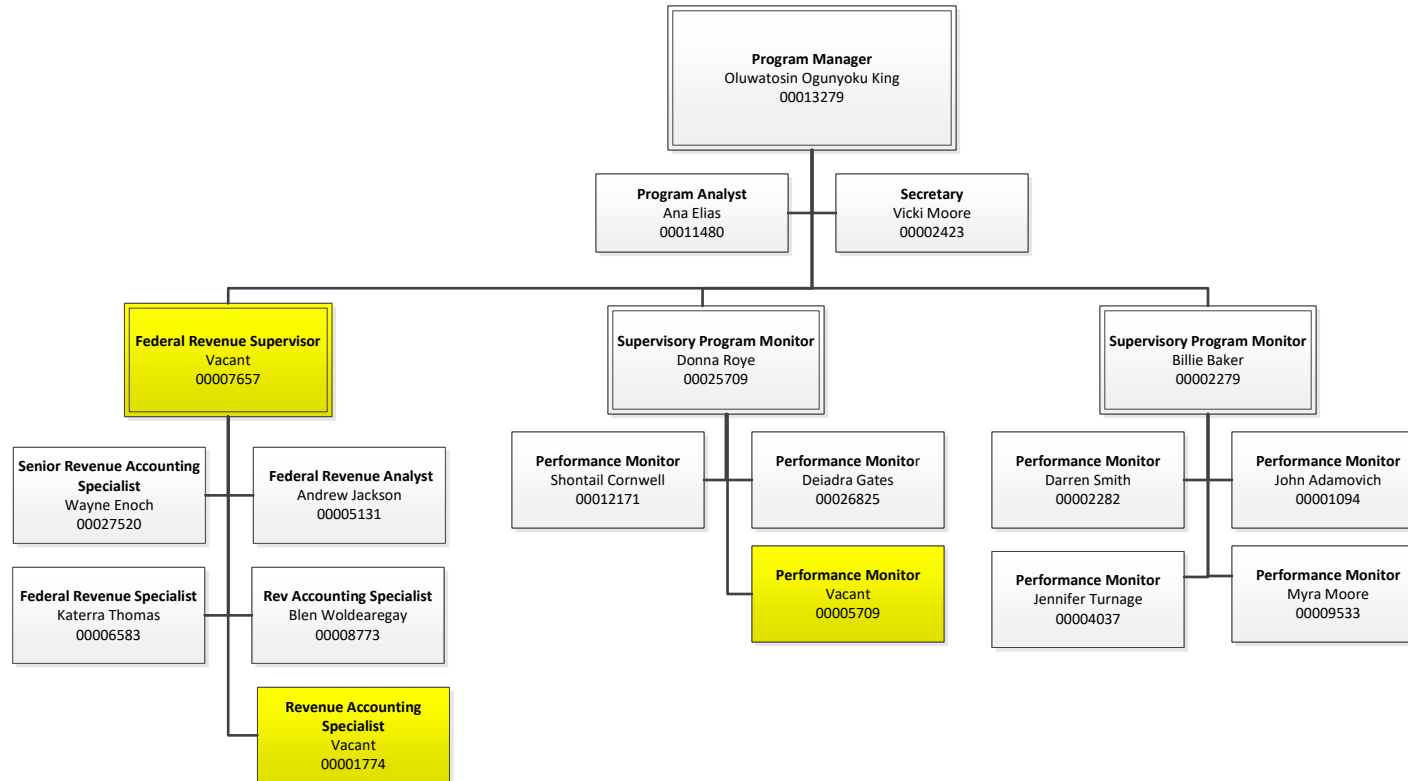


ODDA: Business Services Administration Overview

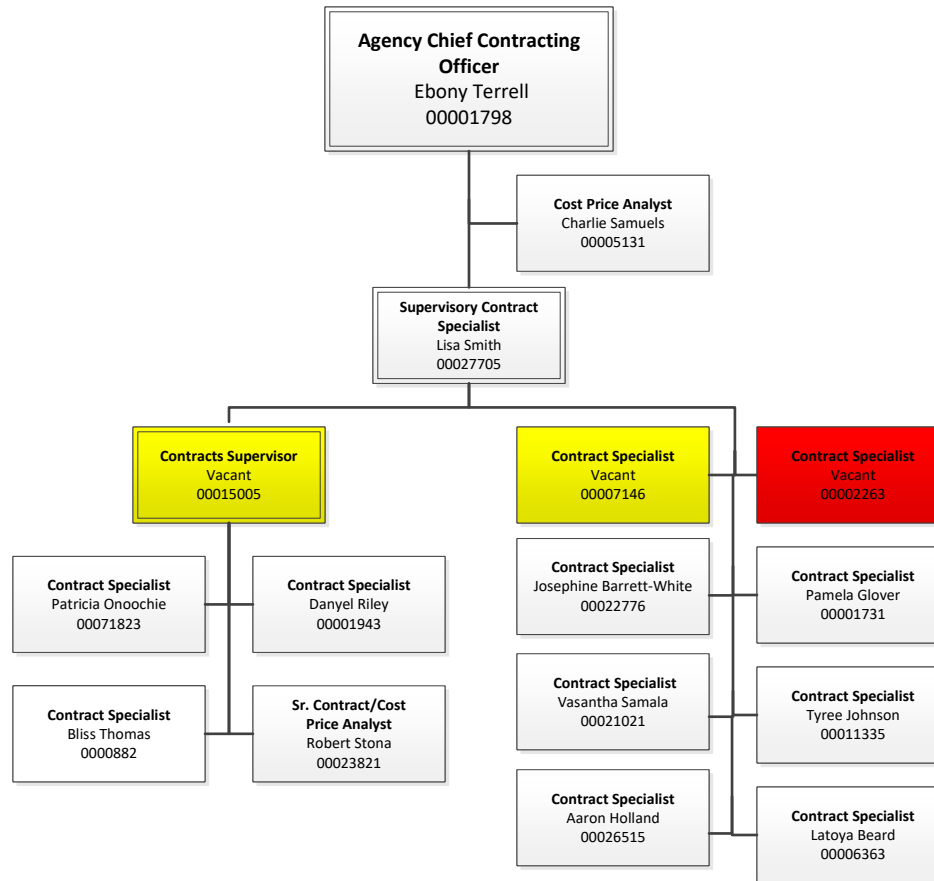




ODDA: Contracts Monitoring Division
