Foster parents to receive incentive payments for 12 straight months of care

While we can't thank Resource Parents enough for all that you do to support kids in care, we've found a tangible way to show appreciation for your long-term commitment to fostering our children and youth. Starting next month, CFSA will offer placement stability incentives to both CFSA and National Center for Children and Families Institute (NCCF) Resource Parents in the amount of \$1,100.00, when a child or youth has maintained placement with a single resource family for 365 days. This year, CFSA had 91 District foster parents and 69 NCCF parents who provided stable placement to a total of 206 youth. Under the conditions of respite, hospital stay or runaway/ abscondence, CFSA will allow for breaks in placement when the child or youth returns to the same provider. Resource parents who have youth placed in their home for 12 consecutive months will be eligible to receive placement stability incentive on an annual basis in the month following the 12th consecutive month. Ways Resource Parents receive reimbursements for damages

For some Resource Parents, damages and property loss can occur while housing a child in CFSA's custody. Under some circumstances CFSA will provide reasonable compensation to parents. However, CFSA does not provide reimbursement for damages resulted from normal wear and tear or gradual deterioration of real property or the Resource Parent's action, inaction, or negligence contributed substantially to the damage. To claim or not to claim? CFSA sheds light on tax filings

While the 2019 tax filing deadline has passed here's important information for Resource Parents who may have filed for an extension. This information is also important for all Resource Parents in preparation for future tax filings.

For Resource Parents, payments received from CFSA are excluded from income and should not be reported on a tax return — this also includes certain difficulty of care payments. Foster parents may be able to claim a foster child if he or she meets several tests – which include the Citizen or Resident Test, Qualifying Child Test, Qualifying Relative Test and Taxpayer Identification Test. Additionally, parents can deduct expenses that are unreimbursed out-of-pocket expenses to feed, clothe and care for the foster child that are incurred to benefit the qualified organization.
