Mayor Bowser Launches Ten New Family Success Centers

This month marks the official opening of the ten new Families First DC Family Success Centers located in Wards 7 and 8. The goals for the Family Success Centers are simple: meet families where they are to help them navigate the District's many resources and connect to critical prevention resources.

From employment and education to food security, childcare, and healthcare, including mental health, each center's priorities were determined by its surrounding community to identify where there are gaps in serving families and customize support to fit their needs.

Last week, when Mayor Bowser and Director Donald officially launched all ten centers at a small press event on the terrace of Ward 8 grantee Martha's Table at the Commons, they agreed "... when we put families first and support children and parents, the whole community benefits."

CFSA Recognizes National Domestic Violence Awareness Month

October is National Domestic Violence Awareness Month. Domestic violence (DV), also known as Intimate partner violence (IPV), is a serious, preventable public health problem that affects millions of Americans.

Domestic Violence by the Numbers

- An estimated 15.5 million children in the U.S. live in families that experience partner violence
- One in four women experience intimate partner abuse
- 99 percent of victims also experience financial abuse
- One in three high school students report physical or sexual abuse (or both) by a teen dating partner

This September, for the fifth year in a row, CFSA celebrated National Kinship Care Month by honoring all of our kinship caregivers. These include formal kinship foster parents and informal kinship caregivers like clients from the Grandparent Caregivers Program and the Close Relative Caregivers Pilot Program.

Huge shoutout to the Kinship Team for keeping the tradition strong this year and rallying to host a Kinship Caregivers Zoom House Party with interactive games and distribute a celebratory feast to kinship caregivers from 200 I St SE.

Kinship caregivers play a critical role in keeping children safe, stable, and well. Last year,

approximately 30 percent of CFSA foster youth were placed in care of kin. The love and stability these families provide is supported by the engagement and connections built by our dedicated Kinship Team.
