## **Resource Parent Improves Placement Process with New Form**

At DC Child and Family Services Agency (CFSA), we want to ensure that children are matched to the foster home that can best meet their needs.

As an innovative idea CFSA resource parent and adoptive parent, Patrick Foley developed a form that described himself and his village which allowed for the youth-in-care and social worker to view information, basic house rules, pictures and expectations from his family as part of the placement planning process. <section-header><section-header><section-header><section-header>

"I came up with this form because I had trouble getting the agency to understand

why I only wanted to accept teen boys who identify as gay. To remedy the challenge, this form is a way for youth to see their potential family and to assist the agency in making the best match for my family," said Mr. Foley.
